### AGREEMENT AND PLAN FOR DISSOLUTION AND LIQUIDATION OF MICROMEDIA AFFILIATES OF FLORIDA, INC.

WHEREAS, the undersigned, being all of the stockholders and directors of MICROMEDIA AFFILIATES OF FLORIDA, INC., a corporation organized under the laws of the State of Florida, have determined that is would be advisable and in the best interests of the corporation and its shareholders for the corporation to be dissolved, and hereby take the following actions by written consent in lieu of a Special Meeting pursuant to Section 607.1402 of the Florida Business Corporation Act;

NOW, THEREFORE, be it:

- 1. RESOLVED that the shareholders of MICROMEDIA AFFILIATES OF FLORIDA, INC. hereby consent to the dissolution of the corporation and to its liquidation pursuant to Section 331 of the Internal Revenue Code or such other Section(s) as the corporation's accountant deems advisable;
- 2. RESOLVED FURTHER, that the officers and directors of MICROMEDIA AFFILIATES OF FLORIDA, INC. are authorized and directed to take all actions necessary to wind up the affairs of the corporation, including the lease, sale, conveyance, or assignment of any or all of the corporation's assets and to execute any documents or instruments necessary and incident thereto;

RESOLVED FURTHER, that the Officers and Directors of MICROMEDIA AFFILIATES OF FLORIDA, INC. are authorized and directed to apply the assets, in cash or in kind, of the corporation to the payment of its known debts and obligations, and after disposing of the assets of the corporation and making suitable provisions for the payment of all of its known debts, the Officers and Directors are authorized and directed to distribute the remainder of the corporation's assets, if any, to the shareholders, in cash or in kind, according to their respective rights and interests;
- 4. RESOLVED FURTHER, that Norman B. Tomlinson, Jr., is appointed trustee in liquidation, and that the Officers and Directors are hereby authorized and required to execute all documents, instruments, reports, tax returns, certificates, and affidavits required by any federal, state or local government in connection with or by reason of the liquidation and dissolution of MICROMEDIA AFFILIATES OF FLORIDA, INC. or on behalf of the corporation, including U.S. Treasury Department Form 966, and Articles of Dissolution with the Florida Secretary of State;
