

Pursuant to 607.1403, Florida Statutes, this Florida profit corporation submits the following articles of dissolution:

FIRST: The name of the corporation is: CL ALLIANCE 2, Inc. previously dba Alliance Property Systems. The name was changed to Alliance Property Systems, Inc. and filed on July 29, 1993 and the name was transferred to an unrelated company.

SECOND: The filing date of the articles of corporation was June 15, 1990. The date of dissolution was authorized March 1, 2002.

THIRD: The corporation's shares were issued to a single owner, one and the same as the President and Chairman executing this dissolution. The sole stockholder, board member and officer approved this dissolution. The number of votes cast for dissolution was sufficient for approval.

FOURTH: There are no remaining assets held by the corporation. All assets were liquidated and applied to outstanding debts.

FIFTH: There were no net assets remaining after winding up operations for distribution to the sole shareholder. This was approved by the sole stockholder.
