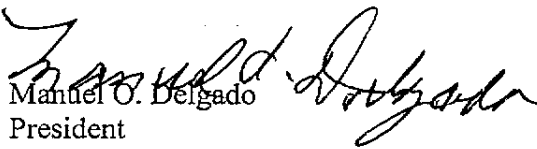

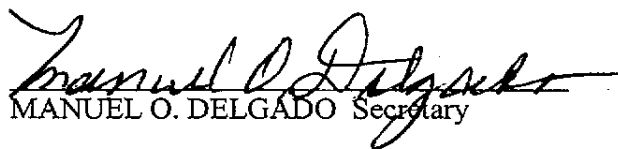
1. The name of the corporation sought to be dissolved is CARBON DIOXIDE EQUITIES, INC.

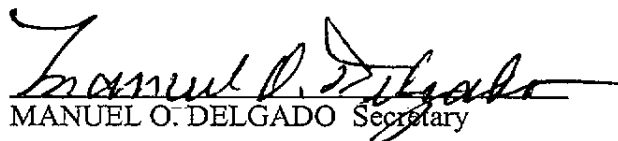
