FLORIDA KEYS ENGRAVING COMPANY**

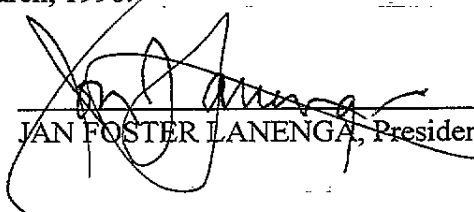

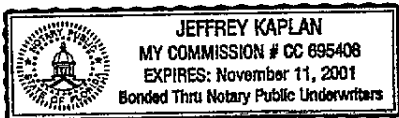
