2. The foregoing amendments were adopted by the Stockholders and Directors on June 6, 2002.

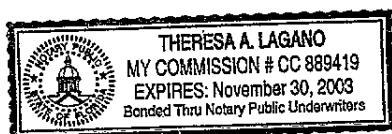
