On July 11, 2001, I received my initial UBR for 2001. I waited until the weekend to do pay my bills and catch up on correspondence. It was at this time that I noticed that the form that I had received was a follow-up form from your office instead of the initial report that I had always received in the past from my registered agent.

I called your office yesterday to ask when the forms are sent out each year. A man named Andy, as I recall, told me that they are mailed out in January. This amazed me because in all the years since my incorporation in 1990 I never received the UBR any earlier than late March or early April. I changed my registered agent a couple of years ago and last year he didn't get it to me until a couple of weeks before the deadline. Andy also told me that the forms are always sent to the corporation's mailing address rather than the registered agent and again I found that hard to believe because I had never, until this year, received one directly.

I called my registered agent, Philip Lupo, yesterday to ask if perhaps my form had been misplaced or filed and he returned my call today and said that they had never received one at all. He may be telling the truth but there has been a problem between he and I over the last year because I have remained friendly with the woman he is currently divorcing and with whom he is going through a bitter child custody battle.

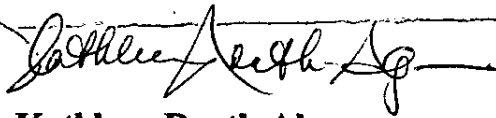
