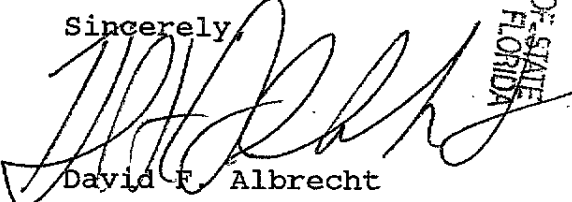

**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
ENVIROMETRICS, INC.**

ENVIROMETRICS, INC., a Corporation organized and existing under the Laws of the State of Florida pursuant to Articles of Incorporation assigned Document Number L82606 filed in the Office of the Secretary of State on June 25, 1990, hereby certifies as follows:

1. By written action dated June 22, 1998, the Board of Directors and Shareholders of the Corporation adopted the following resolutions:

**RESOLVED** that the Articles of Incorporation of ENVIROMETRICS, INC. be amended so as to change the name of the Corporation to **BROBINA, INC.**, and that Article I shall be amended to read:

"The name of the Corporation shall be **BROBINA INC.**, hereinafter referred to as the corporation."

**RESOLVED** that the street address of the principal office of the Corporation has been changed to: 345 34th Court, SW, Vero Beach, Florida 32962.
