



Pursuant to the provision of Chapter 607, Florida Statutes, the undersigned corporation adopts the following articles of amendment to it's articles of incorporation.

FIRST: The name of the corporation is:

O'TUOHY ENTERPRISES LIMITED, *R.T., INC.*

SECOND: The following amendments to the articles of incorporation were adopted by the corporation:

Article "1." is deleted and in it's place and stead, the following:

1. The name of the corporation is R-S LITTLE PRINCESS LTD., *R.T., INC.*

Article "IV" is deleted and in it's place and stead, the following:

4. The corporation is authorized to issue 2,000 shares, of one class, at twenty-five cents par value.

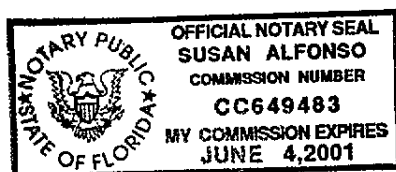
