Pursuant to the provisions of Section 607.1101 of the Florida General Corporation Act, the undersigned corporations adopt the following Articles of Merger for the purpose of merging them into one of such corporations:

1. The following plan of merger was approved by the board of directors and shareholders of each of the undersigned corporations in a manner prescribed by the Florida General Corporation Act:

a. All shares outstanding of Copyrite, Inc. shall be surrendered to the secretary of Copyrite, Inc.

b. All shares outstanding of Brantley Printing, Inc. shall be surrendered to the secretary of Brantley Printing, Inc.

c. The secretary and president of Brantley Printing, Inc. shall cause to be issued to Gary L. Mudge 1,000 shares of Brantley Printing, Inc.

d. The federal tax identification number of the surviving corporation, Brantley Printing, Inc., shall remain and continue to be number 59-3015256.

2. The date of adoption of the plan of merger by Brantley Printing, Inc. was on October 1, 1997, and by Copyrite, Inc. on October 1, 1997.

3. As to each of the undersigned corporations, the number of shares outstanding and the designation and number of

outstanding shares of each class entitled to vote as a class on such plan, are as follows:

a. Copyrite, Inc.; 100,000 shares outstanding; all common stock.

b. Brantley Printing, Inc.; 1,000 shares outstanding; all common stock.

4. As to each of the undersigned corporations, the total number of shares voted for and against such plan, respectively, and, as to each class entitled to vote thereon as a class, the number of shares of such class voted for and against such plan respectively are as follows:

a. Brantley Printing, Inc.; all 1,000 shares of common stock outstanding, being the only class, voted for the plan.

b. Copyrite, Inc.; all 100,000 shares of common stock, being all of the stock outstanding, voted for the plan.
