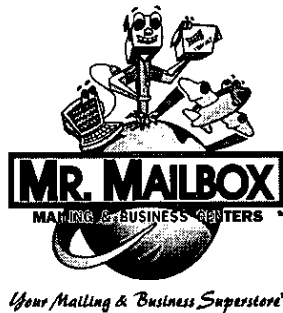

To Whom It May Concern:

Pursuant to our recent telephone conversation with Justin of your office, please find enclosed the Application for Reinstatement of our corporation Mr. Mailbox, Inc. Please be advised that I had filed, on February 11, 2003, the original Uniform Business Report (UBR) for timely filing.

It appears after some investigation that your office either never received or misplaced the above mentioned report as the filing was never documented. This matter only recently came to my attention when I received the Delinquency Notice and the Application for Reinstatement. It is interesting but untimely that I received both of these documents during the same two week period but after the status of our corporation had been revoked. Unfortunately, I was on vacation when the Delinquency Notice was received or I would have contacted your office earlier this month in this regard. We are located in a very small town, and historically, it is not that uncommon for our mail delivery to be delayed and sometimes even lost.
