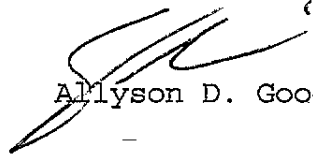

The undersigned, for the purpose of dissolving this corporation due hereby adopt the following Articles of Dissolution:

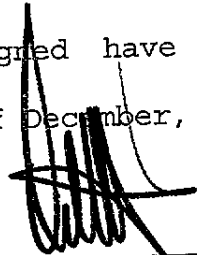
ARTICLE I - NAME

Articles of Dissolution this 31st day of December, 1999.

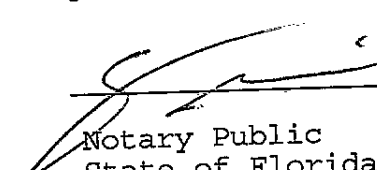
