Dear Sir/Madam:

In accordance with my telephone conversation this morning with Barbara in your Corporation Reinstatement Department regarding Donalga, Inc. ("Donalga"), enclosed are:

1. Executed Corporation Reinstatement Form for Donalga; and
2. Check No. 7016 from Alan Rosenthal in the amount of \$450, representing payment for the Uniform Business Report filings for the years 2001, 2002 and 2003.

In October, 2001, Donalga received a Notice of Administrative Dissolution or Revocation. On October 15, 2001, Alan Rosenthal, an officer and registered agent for Donalga, forwarded a letter ("October 15 letter") to the Secretary of State ("State"). The October 15 letter informed the State that the 2001 Uniform Business Report for Donalga and a check for \$150, were timely sent on January 14, 2001. Apparently, the report and check were lost and a newly executed Report and check, payable to the State for \$150 were enclosed in the October 15 letter. The October 15 letter, with enclosures, was received by the State on October 16, 2001 and signed for at 9:23 a.m. by B. Sippio.



On October 26, 2001, the State forwarded a letter to Donalga, acknowledging receipt of the October 15 letter and its enclosures. The State's letter explained that Donalga did not accurately provide details on the mailing regarding the 2001 Uniform Commercial Report and therefore would not be reinstated without providing a more detailed account of the Report initially filed. Mr. Rosenthal's Check No. 6338 and the newly executed Report were returned with this letter. However, this letter was never received by Donalga. In my follow-up conversation with the State on October 27, 2001, I confirmed the receipt of the October 15 letter and asked if there was any additional information needed for reinstatement. During this conversation, I was not informed of the October 26, 2001 letter sent from the State denying reinstatement of Donalga.

Thereafter, as Donalga was not reinstated as a corporation, the Uniform Commercial Report for 2002 was not forwarded from the State, and subsequently, no filing fees were paid.

Donalga seeks a waiver of the additional fees for reinstatement based upon the detailed chronology of events as listed above.
