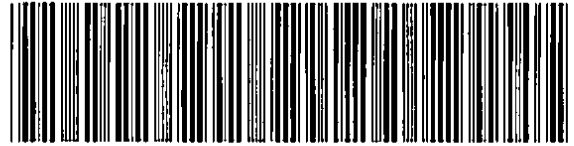

BBWP Inc.

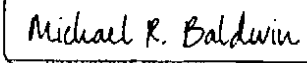

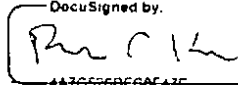
