To whom it may concern:

My name is "D.J." Donald H. LaDez Jr. I am the General Manager of Lumedyne, Inc. in Port Richey, Florida. We have a problem with our corporate officers and registered agent listed in your public records. It has been wrongfully changed recently.

In regards to Lumedyne, Inc, a Florida Corporation, solely owned by Anne O. Green (formerly Anne O. Vogt). This Corporation was owned 50/50 with her late husband William J. Vogt who passed away in January of 2000. Anne was granted 100% full ownership through the contractual "right of survivorship" upon William's death. This was contested by Laura A. Vogt (William's daughter) yet through the due legal process of the business and the estate of William J. Vogt, Anne was proven to be both the sole owner of the Corporation and the sole executor of his estate. On a side note, Anne also purchased John Vogt's interest in any real estate involved in the estate of William J. Vogt. This made Anne the sole beneficiary of all assets.

We have had several issues with Laura Vogt since William's demise. These started in 2000 when Laura filed a fictitious UBR on March 8, 2000 changing all of the officers and the personal representative to herself. She later attempted to change the County Occupational License as well (which was reversed and then permanently locked to the corporation). We proved with legal documentation that she was not, nor is not a party to these positions. Detective Smallwood of the Pasco County Sheriff's Department contacted her at that time and warned her that this constituted fraud and that she should cease and desist such actions. The State Attorneys office chose not to pursue fraud charges against her as no damage to the corporation was done. We returned the titled positions to the rightful persons with the UBR filed on August 18, 2000.

During 2001 we also had to defend the company and William's estate against Laura A Vogt. We were also successful in that defense as well. See the attached strike against her claim from September of 2001.

Now in 2002 she has done it again by again filing a fictitious UBR with your office on May 6, 2002. We have again contacted Detective Smallwood and the State Attorney. It is likely that they will pursue fraud charges this time as she already had an official

warning in 2000 and lost other claims in 2001. I can provide additional contact information for our local State Attorney or Detective Smallwood if necessary. Our legal personal representative, Al Torrance is also involved and is named on all of the UBR's except Laura's. Our corporate lawyer, Al Torrance can be reached at 727-845-6224 or by mail as noted in box 6 of the real UBR's for several years.

Please help us to return the directors back to Anne O. Vogt (or currently remarried as Anne O. Green) as was stated on our genuine UBR filed on April 3, 2002. Please note that Laura is also NOT our Treasurer, nor does she have any legal ties to the company. We actually have a Trespass Warning against her since 2000 so that if she were to show up here, the Port Richey Police Department would arrest her. Laura Vogt has no documentation other than printouts from the Department of Corporations web site and a batch of fraudulent business cards that show any ties legal or otherwise to the company.

Please contact me with your decision or request for more documentation as soon as possible. We have now received a document from the Florida Department of Labor and Employment Security denying Anne O. Vogt (Green) from her Worker's Compensation exemption, as she is not named as an officer of the company on your listing. We also would not receive any legal documents filed against the company as the registered agent was also changed to Laura's personal information.
