## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

\* CORPORATE SYSTEMS GROUP, INC.

Pursuant to the provisions of Section 607.1003 of the Florida Business Corporation Act, as amended (the "FBCA"), the Articles of Incorporation of Corporate Systems Group, Inc., a Florida corporation (the "Corporation"), is hereby amended as follows:

"Arricle III" is deleted in its entirety and amended to read as follows:

## ARTICLE III

A. The aggregate number of shares of capital stock that this Corporation shall have authority to issue is TEN THOUSAND (10,000) shares of common stock, par value \$.001 per share.

The foregoing Amendment was proposed and duly approved by the Corporation's shareholders and Board of Directors by joint written consent in lieu of a meeting on April 4, 2000, pursuant to Sections 607.0704 and 607.0821 of the FBCA. The number of votes cast for the amendment was sufficient for approval.

In accordance with Section 607.0123(1)(b) of the FBCA, this Amendment shall be effective upon its filing with the Florida Department of State.
