ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

HARROD PROPERTIES, INC.

HARROD PROPERTIES, INC., a corporation organized and existing under the laws of the State of Florida, hereby certifies as follows:

Pursuant to written action of the sole Shareholder and member of the Board of Directors of the Corporation, in lieu of holding a special meeting, the following resolution was adopted on Siphimics, 2006, amending the Articles of Incorporation:

RESOLVED, that Article VI of the Articles of Incorporation filed with the Secretary of State of Florida be amended as hereinafter set forth:

"ARTICLE VI

Capital Stock

The corporation is authorized to issue Two Hundred Thousand (200,000) shares of capital stock having a par value of One Dollar (\$1.00) per share, which shall be designated "Common Stock", as follows:

- (1) Ten Thousand (10,000) shares of voting common stock, which shall be designated "Voting Common Stock"; and
- (2) One Hundred Ninety Thousand (190,000) shares of nonvoting common stock, which shall be designated "Nonvoting Common Stock".

Other than the difference in voting rights described above, all shares of Common Stock shall have the same rights and preferences.

WHEREUPON, at Tampa, Florida, this 15+ day of September, 2006, the Corporation has caused its Chief Executive Officer to execute these Articles of Amendment to Articles of Incorporation, so that, on the filing hereof, the Articles of Incorporation shall be deemed amended accordingly.
