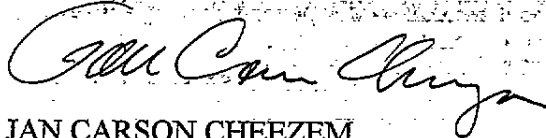

**CERTIFICATE OF AMENDMENT
TO
ARTICLES OF ORGANIZATION

1. The name of the limited liability company is LEMAR L.C.
