1. The name of the limited liability company is Arista Enterprises, L.C.
2. The effective date of the limited liability company's dissolution is at midnight on December 31, 1996.
3. A description of the occurrence that resulted in the limited liability company's dissolution pursuant to section 608.441, Florida Statutes: At midnight on December 31, 1996, all the members contributed their member interest in Arista Enterprises, L.C. to Arista Enterprises, Inc. a Florida corporation, (the "Corporation") in a transaction qualifying under Section 351 of the Internal Revenue Code of 1986, as amended, and furthermore, pursuant to applicable Florida law, all members consented to the assignment and, also, to the admission of the Corporation as a member. Because the contribution left Arista Enterprises, L.C. with less than two members, a dissolution was caused pursuant to Section 608.441(1)(d), Florida Statutes.
4. All debts, obligations and liabilities of the limited liability company have been paid or discharged.
5. All remaining property and assets have been distributed among its members in accordance with their respective rights and interests.
6. There are no suits pending against the company in any court.
