The name of the limited liability company (hereinafter referred to as the "Company") is TOTAL GOLF CONSTRUCTION, L.C.

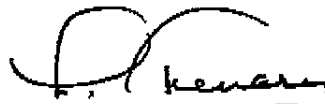
2. Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.
