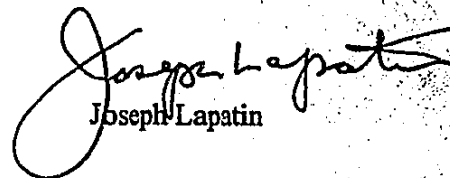
I thank you for the courtesy extended me during our conversation this afternoon regarding my client above named. You were very helpful in expediting the process so that Anido L.C. can be restored to proper status. As per your direction I enclose herewith a check in the amount of \$477.50 representing a payment for the filing fees to bring the entity current. As mentioned to you on the phone, on February 12 I forwarded the report to William J. Stewart, Esq. in Vero Beach, Florida for him to sign at paragraph 9 as the registered agent and for him to forward the form with my check in the amount of \$238.75 as a fee in filing the annual report.
