# AMENDED AND RESTATED ARTICLES OF ORGANIZATION 21 PM 4:15 OF PRIMARY CARE ASSOCIATES, P.L. TALLAHASSEE, FLORIDA

The undersigned having associated together for the purpose of becoming a Professional Liability Limited Company for providing for the formation, rights and privileges and immunities of limited liability companies for profit, in accordance with the Florida Statutes, Section 608.411, does hereby amends its Articles of Organization in its entirety and hereby adopts the following Amended and Restated Articles of Organization for the purpose of converting to a Limited Liability Company:

## ARTICLE I.

The name of the Limited Liability Company shall be Primary Care Associates, L.C.

## ARTICLE II. DURATION; EFFECTIVE DATE

This Limited Liability Company shall exist for a period commencing as October 17, 1994 which is the date the Articles of Organization were filed with the State of Florida Department of State and terminating on December 31, 2004.

## ARTICLE III. ADDRESS; PRINCIPAL OFFICE

Existing members shall have the right to admit new members by consent of members representing seventy five percent (75%) of the ownership interests in the Limited Liability Company. A member's interest in the Limited Liability Company may not be sold or otherwise transferred except with the written consent of members representing at least seventy five percent (75%) of the ownership interest of the Limited Liability Company and must be otherwise in accordance with the Regulations of this Limited Liability Company.

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the Limited Liability Company, the remaining members shall have the right to continue the business upon unanimous consent of such remaining members.
