AMENDMENT TO ARTICLES OF ORGANIZATION

OF

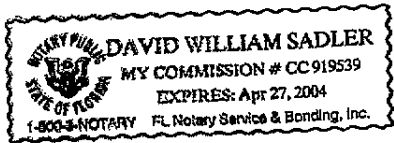
