**CERTIFICATE OF AMENDMENT  
TO ARTICLES OF ORGANIZATION OF  
WEBB, MCQUEEN & COMPANY, P.L.**

This Certificate of Amendment to Articles of Organization of Webb, McQueen & Company, P.L., a Florida professional limited liability company, ("Certificate of Amendment") is executed this 3<sup>rd</sup> day of December, 1998, to become effective on the later of January 1, 1999 or the date of the filing of the Certificate of Amendment with the Secretary of State of the State of Florida (the "Effective Date").

**RECITALS**

A. The name of the professional limited liability company which articles of organization are being amended hereby is Webb, McQueen & Company, P.L. (the "Company"). The articles of organization of the Company were filed on December 29, 1994 and were assigned document number L94000000729 (the "Articles of Organization").

B. Paula F. McQueen has announced her retirement from the Company effective December 31, 1998, has assigned her interest in the Company to the Company by that Assignment, Acceptance and Consent dated the same date of this Certificate of Amendment effective as of the Effective Date and has dissociated herself from the Company effective as of the Effective Date. All members of the Company have consented to such retirement, assignment and dissociation.

C. Geoffrey L. Lorah shall become a member of the Company as of the Effective Date pursuant to the terms of agreement between the Company and Geoffrey L. Lorah.

D. The members of the Company desire to change the name of the Company as hereafter set forth.

**AGREEMENT**

Now, therefore, in consideration of the premises and other good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, the Articles of Organization of Webb, McQueen & Company, P.L. are hereby amended effective as of the Effective Date as follows:

1. Article I of the Articles of Organization is hereby amended in its entirety to read as follows:

*ARTICLE X - MANAGEMENT*

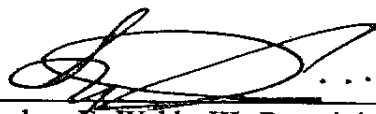

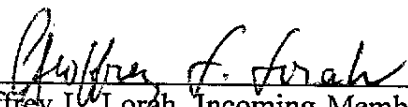
3. This Certificate of Amendment was recommended by the Members of the Company on the date hereof.
