ARTICLES OF ORGANIZATION FOR
PROFESSIONAL LIMITED LIABILITY COMPANY**

These Amended and Restated Articles of Organization amend and restate in their entirety those Articles of Organization of Webb, McQueen & Company, P.L. which were filed on December 29, 1994 with the Florida Department of State under document #L94000000729 as amended by that Certificate of Amendment to Articles of Organization filed on December 28, 1998 with the Florida Department of State. These Amended and Restated Articles of Organization are effective upon the later of January 1, 2016 or upon their filing with the Florida Department of State.

ARTICLE I - NAME

The name of the Limited Liability Company is WEBB, LORAH & McMILLAN, PLLC

ARTICLE II - ADDRESS

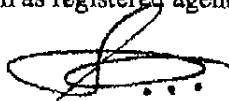
