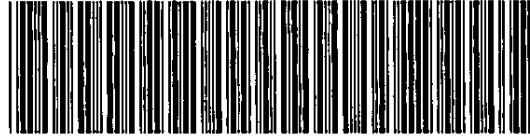

ARTICLES OF INCORPORATION
of

The undersigned hereby files Articles of Amendment to the Articles of Incorporation of CONSTRUCT TWO CONSTRUCTION MANAGERS, INC., (the "corporation") and sets forth the following:

The name of the corporation is CONSTRUCT TWO CONSTRUCTION MANAGERS, INC.

The text of the amendment is: Article VII is deleted in its entirety and in place thereof the following Article VII is adopted:

Article VII

The business of the corporation shall be managed by a Board of Directors consisting of one director. The director shall be elected by the shareholders of the corporation from time to time.
