ARTICLE I

NAME

The name of this limited liability company is Mad Distributors, L.C.

ARTICLE II

DURATION

The Regulations may be adopted, altered, amended or repealed by the members.

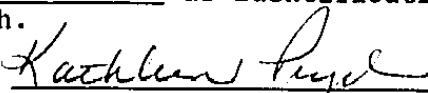
