ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION

OF

MATTER BROTHERS REAL ESTATE, L.C.

Pursuant to the provisions of Chapter 605 of the Florida Statutes, the undersigned hereby declares the following amendment (the "Amendment") was adopted to the Articles of Organization of MATTER BROTHERS REAL ESTATE, L.C., a Florida limited liability company ("the Company") originally filed with the Secretary of State, State of Florida on February 10, 1995, and assigned Florida document number L95000000123:

1. <u>Amendment</u>. Articles II and VIII of the Company's Articles of Organization are hereby amended so as to read, after Amendment, as follows:

"ARTICLE II

DURATION

This Company shall exist perpetually, commencing as of the date of acceptance and filing of these Articles by the Secretary of State of the State of Florida.

ARTICLE VIII

MEMBERS' RIGHT TO CONTINUE BUSINESS

With the consent of all remaining members the remaining members of the Company shall have a right to continue the business of the Company on death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company."

2. <u>Effective Date</u>. The Amendment shall become effective on the date of filing and acceptance of this Amendment by the Secretary of State of the State of Florida.
