ARTICLES OF ORGANIZATION

OF

SANDERS BAYSHORE FARMS, L.C.



THE UNDERSIGNED, R. DAVID SANDERS, JEANNETTE B. SANDERS and KATE SANDERS, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, heroby make, acknowledge, and file the following Articles of Organization.

ARTICLE_I_-_NAME

The name of the limited liability company shall be SANDERS BAYSHORE FARMS, L.C., ("Company"). The principal place of business of the Company in Florida shall be: 2424 Ephraim Street, Fort Myers, Florida 33907-4315.

ARTICLE II - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed with the Florida Department of State. The Company's existence shall terminate not later than thirty (30) years from the date of filing of these Articles with the Florida Department of State unless the Company is earlier dissolved as provided in these Articles of Organization.

Each member shall make additional capital contributions to the Company only upon the unanimous consent of all the members.

ARTICLE VII - ADMISSION OF NEW MEMBERS

The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least two remaining members.

ARTICLE IX - MANAGEMENT

The Company shall be managed by the members in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
