# ARTICLES OF ORGANIZATION OF NAPLES LAND COMPANY, L. C.



#### ARTICLE 1: NAME

The name of this limited liability company shall be NAPLES LAND COMPANY, L. C.

#### ARTICLE IL DURATION

This limited liability company shall exist for a period of twenty (20) years commencing upon the execution and filing of these Articles.
