ARTICLE I

TALLAHASSEE, FLORIDA

The name of the limited liability company ("Company") is Woods, Murray, Farley, L.C.

ARTICLE II

Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.

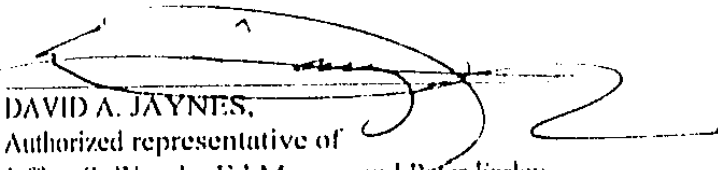
ARTICLE VII
