ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

OF

SOUTHERN SILVICULTURE, L.C.

The undersigned, acting as organizer of a limited liability company under the Florida Limited Liability Company Act, adopts the following Articles of Organization for such company:

ARTICLE I

Name. The name of this Company is SOUTHERN SILVICULTURE,
