The undersigned members hereby join together to form a limited liability company under the provisions of the Florida Limited Liability Company Act (the "Act"), and adopt the following Articles of Organization:

ARTICLE I
Name

The name of this limited liability company is ADC INVESTMENT GROUP, L.C. (the "Company").

EFFECTIVE DATE

ARTICLE II
Duration of Existence

APR - 1 1995

The Company shall commence its existence on April 1, 1995, and thereafter shall remain in perpetual existence, unless and until terminated in accordance with any applicable provision of the Act.

ARTICLE III
Purpose of Organization

The Company is organized to enable its members to transact any lawful business for which a limited liability company may be organized under Florida law.

ARTICLE IV
Address of Principal Office and Initial Registered Agent

The Company's mailing address and the street address of its principal office is 13901 Bruce B. Downs Blvd., Tampa, Florida 33613, and its initial registered agent is Jeremy P. Ross, whose address is 220 South Franklin Street, Tampa, Florida 33602.

ARTICLE V
Assignment of Profits and Management Interest; Additional Members

The members are authorized to admit additional members in the manner set forth in the Company's Regulations and Operating Agreement (the "Regulations").

Continuation of Business
Following Membership Termination

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the business of the Company may be continued only by all remaining members consenting thereto, except as may be set forth elsewhere herein or in the Regulations.

Management of the Company

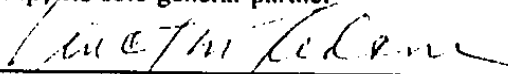

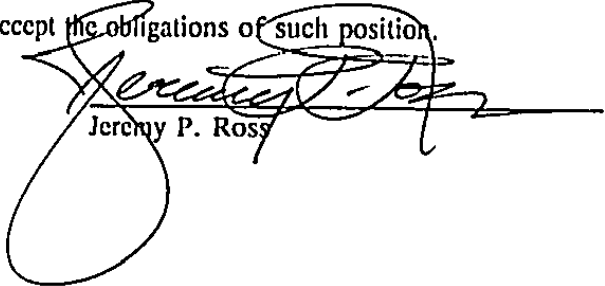
