ARTICLES OF ORGANIZATION
OF
WINSPORT PRODUCTIONS, L.C.

The undersigned adopt the following Articles of Organization for the purpose of becoming a limited liability company under the Florida Limited Liability Company Act.

ARTICLE I

NAME

The name of the limited liability company, referred to in these Articles as "Company", is WINSPORT PRODUCTIONS, L.C.

ARTICLE II

DURATION

The Company shall exist perpetually, beginning on the date these Articles of Organization are filed by the Florida Department of State.

ARTICLE III

MAILING ADDRESS

The mailing and the street address of the Company's principal place of business is 1301 Riverplace - Suite 1609, Jacksonville, Florida 32207.

ARTICLE IV

REGISTERED AGENT AND OFFICE

ARTICLE V

ADMISSION OF NEW MEMBERS

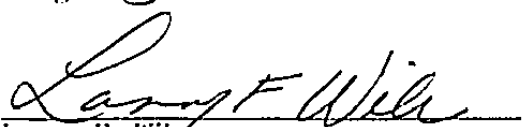

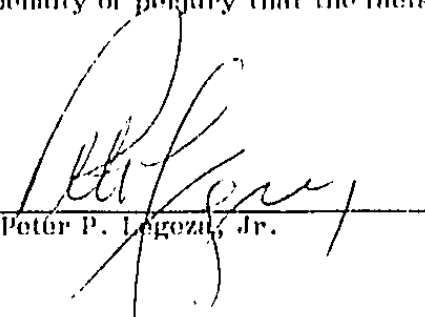
