a Florida Limited Liability Company

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute 608 entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company;

- 1. Name. The name of this company shall be Tortuga Group, L.C.
- Duration/Continuation.
