ARTICLES OF ORGANIZATION OF THE BASSETT-BYRNE COMPANY, L.C.

ARTICLE I - NAME

The name of this limited liability company is THE MASSETT-BYRNE COMPANY, L.C.

ARTICLE II - PURPOSE

The general nature of the business to be transacted by the limited liability company shall be to carry on the business of renovating and rehabilitating real property; and to have and exercise all of the powers now or hereafter conferred by the laws of the State of Florida upon limited liability companies organized pursuant to the laws under which this limited liability company is organized and any and acts, amendatory thereof and supplemental thereto.

ARTICLE III - DURATION

The period of this limited liability company's duration shall be a period not to exceed thirty (30) years from May 1, 1995, or the date of filing of these Articles of Organization with the Florida Department of State, whichever is later.

ARTICLE IV - INITIAL REGISTERED OFFICE AND AGENT


