The undersigned, for the purpose of forming a limited liability company under the laws of Florida, adopts the following Articles of Organization:

ARTICLE I

NAME

The name of the limited liability company is **York Trading Company, L.C.**

ARTICLE II

ADDRESS

The mailing address and street address of the principal office of the limited liability company is 722 Ponte Vedra Boulevard, Ponte Vedra Beach, Florida 32082.

ARTICLE III

DURATION

The period of duration for the limited liability company shall be for a term of forty (40) years, unless sooner terminated and dissolved in accordance with the Regulations. Company existence shall commence on the date these Articles are executed and acknowledged, except that if they are not filed by the Department of State of Florida within

five (5) days, exclusive of legal holidays, after they are executed and acknowledged, company existence shall commence upon filing by the Department of State.

ARTICLE IV

ADMISSION OF ADDITIONAL MEMBERS

All prospective members must be approved by the affirmative vote of the managing member and the affirmative vote of a majority in interest of the remaining members. The capital contribution to be made by such prospective additional member shall also be determined by the managing member and by a vote of a majority in interest of the remaining members

ARTICLE VI

MEMBERS RIGHTS TO CONTINUE BUSINESS

The right, if given, of the remaining members of the limited liability company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company shall be:

The remaining members shall have the right to continue the limited liability company. A decision to continue the business shall be determined by an affirmative vote of a majority in interest of all remaining members to continue the business upon the termination of one member's interest.

AMENDMENT

This company reserves the right to amend or repeal any provision contained in these Articles of Organization, and any right conferred upon the members is subject to this reservation.

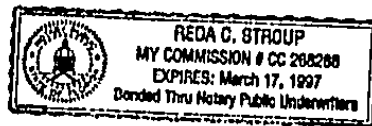
