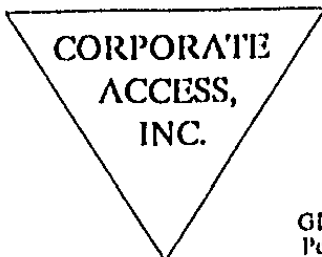

The undersigned make and subscribe to those Articles of Organization intending to form a limited liability company under the provisions of Florida Statutes Section 608.407.

ARTICLE I.

The name of the limited liability company shall be WETCLEANING ENVIRONMENTAL TECHNOLOGIES, L.C.

ARTICLE II.

The duration of the limited liability company is perpetual.

ARTICLE III.

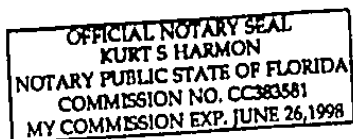

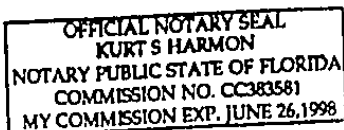

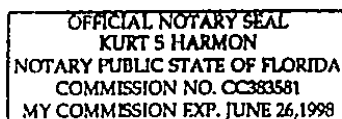
