

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).


EFFECTIVE DATE

05-30-95

1. Name. The name of this limited liability company is Ninja Boy, L.C. ("Company").
2. Duration. The Company shall exist from the date specified in Paragraph 9 until the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the consent of a majority of all of the remaining members, or as otherwise provided in these Articles or the Regulations.
3. Mailing Address and Street Address. The Company's street and mailing address is 1126 S. Division Avenue, Orlando, Florida 32805.
4. Registered Agent and Office. The name of the initial registered agent of the Company is Richard Pabis. The street address of the initial registered agent of the Company is 1126 S. Division Avenue, Orlando, Florida 32805.
5. Additional Members. Additional Members to the Company, or assignees of existing Members, may be admitted upon the consent of a majority of the current Members, subject to the terms and conditions set forth in the Regulations.
6. Termination of Membership. If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, a majority of the remaining members, by written agreement, may continue the business of the Company.
7. Management of the Company. The Company shall initially be managed by the following person who shall serve as manager until the first annual meeting of the members or until his successor is elected and qualifies: Richard Pabis, 1126 S. Division Avenue, Orlando, Florida 32805
8. Regulations. The manager shall have the power to adopt, alter, amend, or repeal regulations of the Company containing provisions for the regulation and management of the affairs of the Company.

9. Date of Existence of the Company. The existence of the Company shall commence on the date of execution and acknowledgment of these Articles of Organization.


