The undersigned, acting as organizers of a limited liability company under the Florida Limited Liability Company Act, adopt the following ARTICLES OF ORGANIZATION for such company:

ARTICLE I. NAME

The period of its duration is perpetual.

ARTICLE III. PURPOSE
