ARTICLE V. MANAGEMENT OF BUSINESS

Except as otherwise provided in these Articles of Organization, all members shall have equal rights in the management or conduct of the Limited Liability Company, pursuant to specific rules regarding rights and duties of members enumerated in the regulations of this Limited Liability Company which are incorporated herein by reference. Decisions shall be by unanimous vote, each member having a vote proportionate to their respective interest in the company. A managing member is: Roy Thomas, 205 SE Milliner Street, Madison, Florida 32340.

ARTICLE VI. TRANSFERABILITY TO MEMBERS' INTEREST

A member's interest in this Limited Liability Company may be transferred only with the unanimous written consent of all the remaining members if the transferee intends to become a member. Without this consent, the transferee shall not be entitled to become a member or to participate in the management of the company, but shall be entitled only to the share of profits, other compensation, or return of contributions to which the transferor otherwise would be entitled.

ARTICLE VII. ADMISSION OF NEW MEMBERS

Additional members may be admitted from time to time with the unanimous written consent of the members.

ARTICLE VIII. WITHDRAWAL, RETIREMENT, DEATH, BANKRUPTCY OR EXPULSION

In the event of withdrawal, retirement, death, insanity, bankruptcy or expulsion of a member, this Limited Liability Company

shall remain in existence and continue in business only upon the consent of all remaining members.

In the event any member desires to withdraw or retire from the Limited Liability Company, or becomes disabled so that he is unable to fulfill his obligations to the Limited Liability Company as specified in these Articles, the member shall give sixty (60) days notice of his intention in writing by registered or certified mail to the other members at the last known address of each member. If any member is adjudged incompetent or insane, his guardian shall give notice thereof to each of the other members in the same manner.

ARTICLE IX. AMENDMENT

These Articles, except with respect to the vested rights of the members, may be amended from time to time by the consent of three-fourths of the members, with each member having a vote proportional to their respective interest in the company, and the amendments shall be filed, duly signed by all members of the company, with the Florida Department of State.

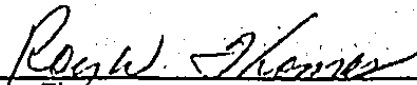

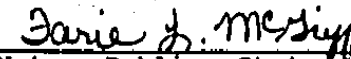
