B.D.W. VENTURES, L. C.

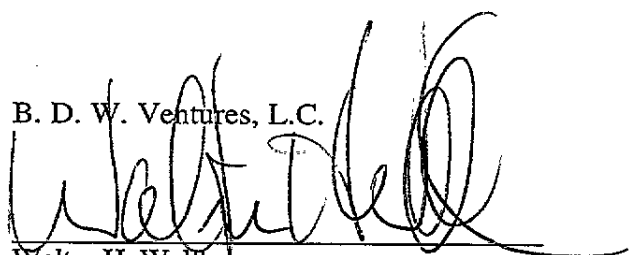
