ARTICLES OF ORGANIZATION

IMPERIAL CROWN, LIMITED COMPANY SECRETARIES (a Florida limited liability company)

The undersigned, acting as the organizers of a limited liability company to be formed under the Florida Limited Liability Company Act, as amended (the "Act"), hereby form a Florida limited liability company (the "Company") pursuant to the Act and hereby adopt the following Articles of Organization (the "Articles").

ARTICLE I. NAME

The name of the Company shall be:

Imperial Crown, Limited Company

ARTICLE II. PRINCIPAL OFFICE

The mailing and street address of the principal office of the Company is: 14502 N. Dale Mabry, Suite 200, Tampa, Florida 33618

ARTICLE III. COMMENCEMENT: DURATION OF EXISTENCE; SINGLE PURPOSE

The existence of the Company will commence on the date of filing of these Articles of Organization, and shall continue for a period of thirty (30) years from the commencement date, or until dissolved by its members in accordance with the Act. The single purpose of the Company is to own the apartment complex in Polk County, Florida called "Imperial Crown Apartments".

ARTICLE IV. MANAGEMENT

The Company is to be managed by a Managing Member and the name and address of the Managing Member is: Joel Cantor, 14502 N. Dale Mabry, Suite 200, Tampa, Florida 33618.

ARTICLE V. ADMISSION OF ADDITIONAL MEMBERS

There is no right to admit additional members except upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of any member, in which event, one additional member may be added upon the majority vote of the remaining members so there will be the required minimum of two (2) members.

ARTICLE VI. MEMBERS RIGHT TO CONTINUE BUSINESS

The remaining members of the limited liability company shall have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company by the

addition of one replacement member upon the majority vote of the remaining members.

ARTICLE VII. REGISTERED AGENT AND OFFICE

The initial registered agent for this Company shall be Joel Cantor, and the address of the registered agent for service of process shall be 14502 N. Dale Mabry, Suite 200, Tampa, Florida 33618.

ARTICLE VIII. PROPERTY

- (a) Ownership. All property originally paid or brought into, or transferred to, this Company as contributions to capital by the members, or subsequently acquired by purchase or otherwise on account of this Company, shall be the property of this Company.
- (b) <u>Title</u>. The title to all property of the Company shall be held in the name of the Company.
- (c) Conveyances. The Managing Member is hereby authorized to convey and obtain title to all real and personal property of whatever nature by the execution on behalf of the Company of any and all agreements, deeds, mortgages, trust agreements, indentures, leases, conveyance documents and all other certificates, instruments and documents as are necessary, reasonable or desirable to obtain title or convey title to any real or personal property whatsoever. Such execution shall be made by the Managing Member. The signature and execution of such documents shall clearly set forth that the execution is on behalf of the Company and that the managing member is singing on its behalf. The following form of signature shall be used for obtaining or conveying title to any real or personal property:

No third party need inquire any further than these Articles of Organization for authorization as to the form of conveyance on documents for title to real or personal property.

ARTICLE IX. REGULATIONS

The members are hereby authorized and directed to prepare and adopt an Operating Agreement and Regulations for the governing of the internal affairs of this Company containing such provisions as they consider necessary, reasonable or desirable, except that no

provisions of the Operating Agreement and Regulations may conflict with the provisions of these Articles of Organizations, unless otherwise permitted herein. The power to adopt, alter, amend or repeal the Operating Agreement and Regulations shall be set forth in the Operating Agreement and Regulations.

In witness whereof, the foregoing Articles of Organization have been adopted by the unanimous vote of the members of Imperial Crown, Limited Company.
