ARTICLES OF ORGANIZATION OF B & N FINANCING AND LEASING L.C.

The undersigned, desiring to form a Limited Liability Company under and pursuant to Section 608.407. the Statutes of the State of Florida do hereby certify as follows:

ARTICLE I Name

The name of said limited liability corporation shall be B & N Financing and Leasing L.C.. The mailing address of B & N Financing and Leasing L.C. is 225 South Westmonte Drive Suite 3000, Altamonte Springs, FL 32714.

ARTICLE II Duration

B & N Financing and Leasing L.C. shall have a duration of twenty years from the date of the filing of these Articles of Organization unless dissolved under one of the events noted in Article VI.

ARTICLE III Operating Agreement and Bylaws

Copies of the operating agreement and bylaws of B & N Financing and Leasing L.C. may be obtained from the Managing Member via a written request mailed to 225 S. Westmonte Dr., City of Altamonte Springs, State of Florida 32714, which is the place in the State of Florida where the principal office of the company is located.

ARTICLE IV

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member, B & N Financing and Leasing L C shall be dissolved

ARTICLE VII Registered Office
