**ARTICLES OF ORGANIZATION OF

The undersigned, desiring to form a Limited Liability Company under and pursuant to Section 608.407 of the Statutes of the State of Florida do hereby certify as follows:

**ARTICLE I  
Name**

The name of said limited liability corporation shall be Muscato Financial Resources L.C.. The mailing address of Muscato Financial Resources L.C. is 225 South Westmonte Drive Suite 3000, Altamonte Springs, FL 32714.

**ARTICLE II  
Duration**

Muscato Financial Resources L.C. shall have a duration of twenty years from the date of the filing of these Articles of Organization unless dissolved under one of the events noted in Article VI.

**ARTICLE III  
Operating Agreement and Bylaws**

Copies of the operating agreement and bylaws of Muscato Financial Resources L.C. may be obtained from the Managing Member via a written request mailed to 225 S. Westmonte Dr., City of Altamonte Springs, State of Florida 32714, which is the place in the State of Florida where the principal office of the company is located.

**ARTICLE IV  
Purpose**

The general purpose or purposes for which Muscato Financial Resources L.C. is formed is to engage in the transaction of any and all lawful business activities for which limited liability companies may be formed under Section 608.407 of the Statutes of the State of Florida.

**ARTICLE V  
Ownership Units**

The maximum number of ownership units which Muscato Financial Resources L.C. is authorized to have outstanding is one hundred (100), all of which shall be identical \$1 par value units, and each of which shall represent the ownership of that percentage of the total units outstanding at any time as is the equivalent of the ratio in which one (1) is the numerator and the total units outstanding is the denominator. Each ownership unit shall entitle the holder thereof to one vote at any meeting and otherwise to participate in all such meetings. Ownership units may be paid for in cash or other property, tangible or intangible, or in labor or services actually performed for the company. Ownership units are non-transferable without obtaining the consent of the other members of Muscato Financial Resources L.C..

**ARTICLE VI**  
**Continuity of Life**

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member, Muscato Financial Resources L.C. shall be dissolved.

**ARTICLE VII**  
**Registered Office**

The street address of the initial registered office of Muscato Financial Resources L.C. is 225 South Westmonte Drive Suite 3000, Altamonte Springs, Florida 32714, and the name of the registered agent of Muscato Financial Resources L.C. is Nick Muscato .

Meetings of the members of the company may be held at places within or without the state of Florida and the place or places for the holding of such meetings may be specified in the Operating Agreement and By-Laws or in the notice of the meeting.


**ARTICLE VIII**  
**Management of Company**

The management of Muscato Financial Resources L.C. is reserved to the members. **ARTICLE IX**  
**Execution of Articles of Organization**

The Articles of Organization of Muscato Financial Resources L.C. shall be executed by Nick Muscato, managing member, of 360 Forest Park Circle, Longwood, Florida 32779.




