ARTICLES OF ORGANIZATION  
OF  
LOYOLA DEVELOPMENT LIMITED COMPANY

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liabilities Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be LOYOLA DEVELOPMENT LIMITED COMPANY (the "Company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company shall be 601 Brickell Key Dr., Suite E, Miami, FL 33131.

ARTICLE III - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved according to law or as provided in these Articles of Organization.

ARTICLE IV - BUSINESS PURPOSE

The Company may engage in any activity or business permitted under the laws of the State of Florida.

ARTICLE V - REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the Company in the State of Florida is Robert M. Haber, 520 Brickell Key Drive, Suite O-305, Miami, Florida 33131.

#### ARTICLE VI - CAPITAL CONTRIBUTIONS

The members of the Company shall contribute to the capital of the Company the cash or property set forth in the Affidavit of Membership and Contributions attached hereto.

#### ARTICLE VII - ADDITIONAL CONTRIBUTIONS

Each member shall make additional capital contributions to the Company only upon the unanimous consent of all the members.

#### ARTICLE VIII - ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and upon such terms and conditions as shall be determined by all members. A member may transfer his or her interest in the Company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

#### ARTICLE IX - TERMINATION OF EXISTENCE


The Company shall be dissolved upon the death, bankruptcy, or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least two remaining members.

#### ARTICLE X - MANAGEMENT

The Company shall be managed by a manager in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with the law or these Articles of Organization. The name and address of the initial manager of the

Company is Jose Luis Llanes, 601 Brickell Key Drive, Suite E, Miami, Florida 33131.
