Name

The name of the limited liability company is York & Associates, L.C.

Article Two

Address of Principal Office

Article Three

Article Four

Period of Duration

The period of duration of the limited liability company shall be from the date of filing these Articles of Organization with the Secretary of State until the occurrence of the earliest of the following events:

- a) the passage of thirty (30) years from the date of filing these Articles of Organization with the Secretary of State; or
- b) the dissolution of the limited liability company pursuant to the provisions of the Florida Limited Liability Company Act; or

c) the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event that terminates the continued membership of a member in a limited liability company, unless the continuation of the limited liability company is consented to by the remaining members as provided for in Article Seven of these articles.

Article Five

Purpose and Powers

The purpose for which the limited liability company is organized is to engage in business consulting services and all other activities and conduct permitted by the laws of the State of Florida. The limited liability company shall have all powers and authority granted by the Florida Limited Liability Company Act.

Article Six

Additional Members

Additional members may be admitted during the existence of the limited liability company upon the agreement of members representing more than 50% of the ownership percentage interests of all the members of the limited liability company prior to the date of admission. The terms and conditions of such admission shall be specified by the members. Ownership percentage interest shall be determined by the capital contributions of the members to the limited liability company. A member's ownership percentage interest shall be the percentage represented by the member's capital contributions to the limited liability company and as adjusted from time to time to properly reflect any additional contributions or withdrawals by the members.

Article Seven

Continuity of Business

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members of the limited liability company shall have the right to continue the business of the limited liability company if members representing more than 50% of the ownership percentage interests of all the remaining members consent to such continuation. The ownership percentage interest shall be determined as set forth in Article Six of these articles.

Article Eight

Management

Additional Capital Contributions

Additional contributions by members will be permitted only upon the vote of members representing more than 50% of the ownership percentage interest of the members in the limited liability company. The failure on the part of any member to make an additional capital contribution may result in a decreased ownership percentage interest. Ownership percentage interest shall be determined as set forth in Article Six of these articles.

Transfer of Ownership Interest

A transferee of a limited liability company interest shall not be admitted as a member of the limited liability company unless approved by a vote of members representing more than 50%

of the ownership percentage interests.

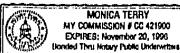
