## ARTICLES OF ORGANIZATION OF FREITES-REVILLA GALLERY OF CORAL GABLES, L.C.

#### ARTICLE I

#### Namo

The name of the limited liability company is Freites-Revilla Gallery of Coral Gables, L.C. ("Company").

#### ARTICLE II

#### Address

The mailing and street address of the Company's principal office is 3200 Ponce deLeon Boulevard, Coral Gables, Florida 33134.

#### ARTICLE III

#### Duration

The period of duration for the Company is perpetual beginning on the date the Articles of Organization are filed by the Florida Department of State.

#### ARTICLE IV

#### Registered Agent and Office

The name of Company's initial registered agent in Florida is David C. Tassell, Esquire. The address of Company's registered office in Florida is 725 N. AlA, Suite C-109, Jupiter, Florida 33477.

#### ARTICLE V

#### Management

The Company is to be managed by the member(s) identified herein. The managing member is identified as follows:

#### ARTICLE VI

#### Admission of New Members

The remaining members of the Company have the right to continue the business on the death, retirement or resignation, expulsion, bankruptcy, insanity, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining members.

#### ARTICLE VIII

#### Additional Provisions

The power to adopt, alter, amend, or repeal the regulations of the Company is vested entirely in the managers listed in Article VII.
