ARTICLES OF ORGANIZATION

OF

SOUTH FLORIDA ENTERPRISES, L.C.

The undersigned acting as organizer of SOUTH FLORIDA ENTERPRISES, L.C., under the Florida Limited Liability Company Act, adopt the following Articles of Organization for said limited liability company.

ARTICLE I NAME

The name of the limited liability company shall be SOUTH FLORIDA ENTERPRISES, L.C. (the "LLC").
