**AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION

The mailing address and the street address of the principal office of the Company is 3776 County Road 507, Wildwood, Florida 34785.


**ARTICLE III - REGISTERED OFFICE AND AGENT**
