ARTICLE I

The name of the Company is KVG Frequency Products, L.C.

ARTICLE II

ARTICLE III

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which pursuant to the Regulations or state law terminates the continued membership of a member in the Company, the remaining members may, by a majority vote, within ninety (90) days, elect to continue the business of the Company. The managing member or members shall forthwith execute and record an amendment to the Articles of Organization to evidence such continuation, if required by appropriate governing law.

ARTICLE VIII

A member may not assign or transfer any portion of its interest in the Company without the prior written ~~unanimous~~ *W.M.* approval of the remaining members and then only in accordance with the Regulations.

The net profits and losses of the Company for any year shall be allocated among the members in accordance with the Regulations.

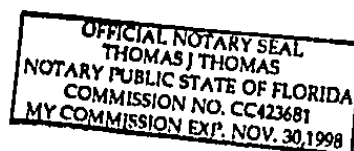


